Applicants who are eligible for more than one of these types of quotas must check all of them and submit the corresponding documentation. If eligibility is verified in more than one situation, the application will be considered in the most favorable one for admission purposes.

For the purposes of the special quotas defined in this document, the following definitions apply:

High Performance Sports Practitioners

Candidates who are high performance sports practitioners, listed for this purpose in the register organized by the Portuguese Institute of Sports and Youth "(IPDJ)" or those who have finished their high performance career within three years of that end, provided that they have never used this special regime during their career.

During their sports life, high performance sportspeople can benefit from the special scheme, provided they meet the necessary conditions.

On the other hand, if the candidate has finished his high performance sports career and has never benefited from the special regime for access to higher education, she/he can benefit within three years of the career end . The student can only use this post-career benefit once.

If the student has benefited from the high performance sports practitioner regime during her/his sports life, she/he can no longer do so after finishing her/his career.

Disabled person

A person who, because of a congenital / acquired loss or anomaly of bodily functions / structures, including psychological functions, has specific difficulties which, in combination with environmental factors, limit or hinder her/his activity and participation on an equal basis with others. Only candidates with a degree of disability equal to or greater than 60% are eligible for these quotas.

Portuguese Emigrants , Family Members living with them and Lusodescendants

Eligible applicants are those who, cumulatively: a) have been resident, on a permanent basis, for at least two years at the time of completing their secondary education; b) submit their application within a maximum of three years after returning to Portugal; c) do not hold a Portuguese or foreign higher education degree; d) have completed their secondary education in their country of residence or their Portuguese secondary education. For this purpose, the following is considered:

Portuguese emigrant - a national who has resided for at least two years, on a permanent basis, in a foreign country where she/he has worked as a self-employed person or as an employee.

Family member of a Portuguese emigrant - spouse, relative or family member in any degree of the straight line and up to the 3rd degree of the collateral line (example: Relatives - Parents, Children, Grandparents, Grandchildren, Great-grandparents, Great-grandchildren, Siblings, Uncles and Nephews; Relatives - In-laws, Stepfathers or Stepmothers, Sons-in-law, Daughters-in-law or Stepchildren, Parents of In-laws or Stepfathers and Stepmothers, Children of Stepchildren, Brothers-in-law, Children of Brothers-in-law and Siblings of In-laws

or Stepfathers and Stepmothers) who have resided with them permanently abroad for a period of not less than two years and who are not older than 25 on December 31st of the year of application. The family member of a Portuguese emigrant is also considered to be the person who

lives with them in a de facto union or common economy, under the terms of specific legislation.

Lusodescendant - A Lusodescendant is a citizen who has resided for at least two years, on a permanent basis, in a foreign country with at least one ancestor of original Portuguese nationality up to the 2nd degree in the straight line who has not lost that nationality, and who has Portuguese nationality under nr. 1, Article 1 of Law nr. 37/81, of October 3rd, in its current wording.
